



MEMORANDUM OF UNDERSTANDING

TO: Commerce guilds with Xarnas home planet

SUBJECT: MOU - PvP Engagement, Xarnas Central Star

EXPIRATION: When adopted, remains in effect as-is until revised or superseded.

OVERVIEW

Now that the migration dust has settled, it is time to get to work on our server. The goal is to rebuild, grow, and provide meaningful activity for all members of 1026.

Below is a proposed MOU meant to help encourage friendly PvP with clear rules, as well as clarify NOVA's intent with Xarnas. This MOU supersedes all agreements, NAPs, or MOUs prior to June 2, 2026.

TERMS

I. RELEVANT PARTIES

- a. This MOU applies to all members of guilds occupying a planet in the Xarnas system.

II. PVP ENGAGEMENT

a. Shrine

- i. Active players at the Xarnas shrine may not be attacked.
- ii. AFK players may be attacked after validation that they are AFK. I.e, observe inactivity for a reasonable amount of time, and circle the target ship(s) as a warning.
- iii. If performing a large AFK cleanup, encourage members to announce in UC to provide time for ship movements out of the area.
- iv. Retaliation attacks are not permitted.
- v. Defending AFK players is not permitted.
- vi. All guilds will remind their members to not AFK at the shrine.

b. PvP/FFA Star System

- i. NOVA proposes using DAX as a pure PvP/FFA arena.
- ii. Attacking trade routes is not permitted.
- iii. Attacking players on a transit route is not permitted.
- iv. Within this system, players not performing trade routes or transiting through a defined path are subject to attack from other players without warning.
- v. All guilds will ensure their members are aware of these rules.

- vi. All guilds will post a guild marker at the center of DAX stating “This is a FFA PvP System. Trade and transit routes are off limits. Have fun.”

c. Hunting Grounds

- i. When hunting grounds are active, FFA rules are in effect across relevant hunting ground systems.

d. Xarnas PvP Event Days

- i. 1026 event:
 - 1. Xarnas system will be FFA with the following exception(s):
 - a. Players within their home planet ring may not be attacked.
 - b. Players actively engaged in PvE may not be attacked. Examples: Shrine, Tributes, Minion, etc. Otherwise, AFK attacks across Xarnas are permitted.
- ii. SvS event:
 - 1. All guilds present in Xarnas during SvS PvP agree to a Non-Aggression Pact (NAP).
 - 2. No AFK kills, no other battles between guilds of 1026.
 - 3. Separately, the guilds will plan the offensive or defensive approach for SvS PvP day.

III. XARNAS CENTRAL STAR

- a. NOVA will retain the Xarnas central star indefinitely at this time, as it has the highest capacity to defend it during events.
- b. NOVA trader prince will ensure all standard titles are in autorotation at all times.
- c. Trade conquerer titles, if available from SvS, will be in autorotation at all times.

IV. ENFORCEMENT AND SEVERABILITY

- a. Participating guilds agree to enforce the terms within their guild and take corrective actions with their members as appropriate.
- b. Participating guilds agree to assist in home planet protection and member protection in the event of aggression/war from non-participating guilds, if needed or requested.
- c. Participating guilds may opt to exit this agreement, however:
 - i. Forfeiture of their Xarnas planet(s) is required.
 - ii. Members of the departing guild are no longer protected by any rules or regulations offered by this MOU.
 - iii. Member guilds may (optionally) enforce these terms by blockading the non-member guild planet and/or declaring war and recovering the planet. The planet would then be offered to an alternate guild in 1026.
- d. Participating guilds may opt to initiate a vote to remove another participating guild due to gross negligence or sustained violations of this MOU. Ample evidence supporting this and a lack of attempted correction must be supplied. In addition, all member guilds must elect a neutral body to serve as the intermediary and additional voting party to ensure fairness. If voted out:
 - i. Participating guilds have full authority to commence a home planet attack.
 - ii. Forfeiture of their Xarnas planet(s) is required.

SIGNATURES/ACCEPTANCE

For the purposes of ratification, this MOU is deemed in effect once it has been agreed upon by the member guilds of Xarnas. The document will be posted in NOVA's Discord in the "1026 High Council" channel. The chairman of each member guild must simply respond to the document thread that it is accepted. Any changes to this document prior to full acceptance will require all signing members below to review and agree again.

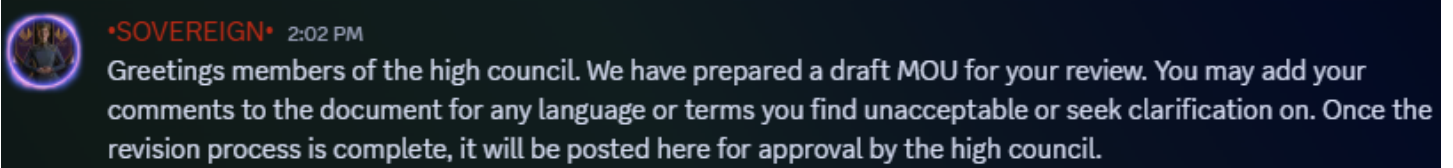

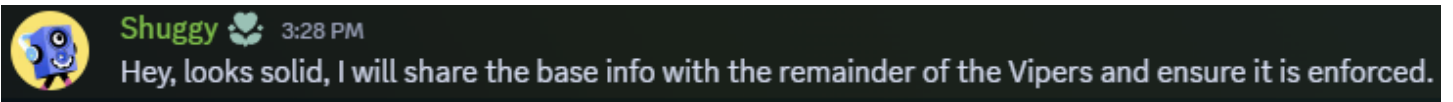
APPROVAL
